Description: Coaches, trains and instructs participants in horse riding by analysing their performances and developing their abilities. Registration or licensing is required.		
Specialisations:	The skill level is appropriate but the courses do not contain adequate training in learning theory, equine behaviour and biomechanics. Currently the focus is on teaching people to ride, without considering how horses need to be trained in a healthy way to ensure their longevity. Animal Care Australia does NOT support the adoption of Equitation Science modules to fill these gaps.

Description: Hunts, traps and shoots animals for food, pelts, research and for pest control. Registration or licensing may be required.		
Specialisations: None	Skill level should be higher to do this professionally and/ or commercially (ie to earn money from it). A cert 1 is barely a token gesture to educate anyone and should only be for people hunting/trapping on their own land, for their own purposes.	Yes, more extensive training is required to raise welfare standards to a minimum acceptable level.

Description: Applies pest management techniques to manage and control animal and invertebrate pests inside and outside domestic, commercial and industrial premises. Registration or licensing may be required.

Animal Management Officer

'Animal Management Officer' is listed in the group '599599 Inspectors and Regulatory Officers not elsewhere classified'. The skill level of this occupation category is: 4 (Cert II or Cert III)

Do you have feedback on separating 'Animal Management Officer' as an occupation?

An inspector is different under the legislation and requires extra education as they have a role in prosecutions and investigations and is generally given special powers under the legislation so yes they should be separate

Animal Management Officers must have animal behaviour certifications that are species specific to the animals they are working with, in addition to regulatory certification

Animal Nutritionist

'Animal Nutritionist' is listed as a specialisation in the group '234115 Agronomist'. The skill level of this occupation is: 1 (Bachelor degree or higher)

Do you have feedback on separating 'Animal Nutritionist' as an occupation?

This is a lacking specilisation, as in order to gain the knowledge it is currently undertaken via private providers. Nutrition is not included in a veterinary qualification and most recommendations currently are given based on supplier rebates, with an increase in animal diseases which can be improved by improved diets an increase in education in this space would be ideal

Animal Trainer and Animal Welfare Officer

'Animal Trainer' and 'Animal Welfare Officer' are both listed in the group '361199 Animal Attendants and Trainers not elsewhere classified'. The skill level of this occupation group is: 4 (Cert II or Cert III)

Do you have feedback on separating 'animal trainer' and/or 'animal welfare officer' as an occupation?



These need to be separated. An animal trainer is someone who undertakes modifications and conditioning on animals to change behaviours where welfare officers are there to ensure the welfare of the animals in a given business

Animal training certification needs to be species specific

Dog Breeder

'Dog Breeder' is listed in the group '121399 Livestock Farmers not elsewhere classified'. The skill level of this occupation group is: 1 (Bachelor degree or higher)

Do you have feedback on separating 'Dog Breeder' as an occupation?

With the current climate of legislative change in which breeding is a huge topic, there is always a need to ensure education is available and should be mandatory as a way of improving overall welfare of animals and breeding practices

Dog Walker

'Dog Walker' is listed in the group '451899 Personal Service Workers not elsewhere classified'. The skill level of this occupation group is: 4 (Cert II or Cert III)

Do you have feedback on separating 'Dog Walker' as an occupation?

Yes it should due to an increase in businesses in this sector

Horse Trekking Guide

'Horse Trekking Guide' is listed in the group '452299 Outdoor Adventure Guides not elsewhere classified'. The skill level of this occupation group is: 3 (Cert IV/Cert III+2 years' on-the-job training)

Do you have feedback on separating 'Horse Trekking Guide' as an occupation?

This should be a separately recognised occupation, however access to training needs to be made more accessible - such as by online learning with on the job practical assessments. Like a mini apprenticeship. This would help with staff retention, and recruitment.

Horse Hoof Carer



'Horse Hoof Carer' is listed as a specialisation in the group '842314 Livestock Husbandry Worker'. The skill level of this occupation is: 4 (Cert II or Cert III).

Do you have feedback on separating 'Horse Hoof Carer' as an occupation?

This is in the Horse Industry. This occupation has in recent years seen a division in the industry, with farriers and blacksmiths continuing in apprenticeship style education pathways, and podiotherapists undertaking university or private college education. These 2 fields have a lot of cross over and need to be standardised to resolve the confusion this is causing to horse owners.
